The name of the issuer is Cleveland-Cliffs Inc. (the "Company").

The Company's principal executive offices are located at 1100 Superior Avenue, Cleveland, Ohio 44114-2589.

- (iv) Tontine Capital Management, L.L.C., a limited liability company organized under the laws of the State of Delaware ("TCM"), with respect to the shares of Common Stock directly owned by TCP;
- (v) Tontine Overseas Associates, L.L.C., a limited liability company organized under the laws of the State of Delaware ("TOA"), which serves as the investment manager for Tontine Overseas Fund, Ltd. ("TOF"), a company organized under the laws of the Cayman Islands, and to certain managed accounts, with respect to the shares of Common Stock directly owned by TOF and the managed accounts; and
- (vi) Jeffrey L. Gendell, with respect to the shares of Common Stock directly owned by each of TP, TCP, TOF and the managed accounts.
